TO CI Complex:

From Sunrise Hwy way out east, go to Southern state pky west, then get off at exit 43a. At the end of the exit there a light. Continue straight after obeying traffic signal and the fields are on the right less than a mile up the road.

From Sunrise Hwy out west, take to Carleton Ave. Head north to Courthouse Lane and make a right (you will pass LI Ducks Stadium on left). Then make a left at the end of the road onto Eastview drive. Take Eastview drive and the fields are on the right less than a quarter mile up the road.

LIE out east take to exit 58. Make a left at the light onto old Nichols road. Stay on and that and it will turn to Suffolk ave, which you will stay west on until Lowell Avenue. Make a left on Lowell, cross the railroad tracks and go four lights and make a right onto Eastview drive at that fourth light. Stay on Eastview drive less than a mile and fields are on the left.

LIE out west get off at exit 56 make a right at the light onto route 111, immediately getting left hand lane and stay left at the fork in the road and that will put you on Carleton Ave. Take that a few miles and make a left onto Courthouse Drive. Then make a left at the end of the road onto Eastview drive. Make a left onto Eastview drive and the fields are on the right less than a quarter mile up the road.

Southern state pkwy from the west Go to exit 43a. Stay right at both forks in road of the exit and get onto Carleton avenue heading north. Head north to Courthouse Lane (2 lights) and make a right. Go one lone block past Ducks Stadium, Then make a left at the end of the road at light onto Eastview drive. Take Eastview drive and the fields are on the right less than a quarter mile up the road.

Southern state pky from Montauk Hwy. Take to exit 43a. At the end of the exit there a light. Continue straight after obeying traffic signal and the fields are on the right less than a mile up the road.
